ZI officer elections for the 2020-2022 biennium were held in early July. All club delegates voted online. Here are the results:

Sharon Langenbeck, Santa Clarita Valley (CA) moved up to International President from the President-elect position (no voting)

Ute Scholz of Verden, Germany - International President-Elect

Salla Tuominen of Helsinki, Finland - International Vice-President (Salla was the Director liaison to District 7 during the 2018-2020 biennium)

District 7 has several things to celebrate. Two resolutions advanced by D7 were up for vote, and one passed. The resolution to allow new members who join in April or May and pay full dues will be considered paid for the new fiscal year starting in June. This will encourage people to become members in the spring instead of waiting until June. The resolution that didn't pass was raising the maximum age of Young Professionals from to 30 to 35. The vote was close at 628 yes and 677 no. Young Professionals have a lower membership fee,

and increasing the maximum age might have encouraged more young people to join.

District 7 also received recognition as one of 20 districts to charter a Z or Golden Z club. St Louis chartered a Golden Z club at Maryville University. Jamestown (ND) chartered a Z Club at Jamestown HS and a Golden Z at University of Jamestown.

At our July meeting, we decided not to participate in the Overland Park Arts & Crafts Festival in September due to concerns about the coronavirus. This has always been a good moneymaker for our scholarships, so let's work on having another fundraiser later in the fiscal year. It's hard to plan anything during these uncertain times. However, we can be ready to have an event when it's safe to do so.

The Kansas primary election is coming up on Tuesday, August 4th. Be sure to vote!
