We want to present programs and activities that are interesting, informative and foster collegiality among our members while promoting lifetime friendships. We also will continue our efforts to increase membership. Zonta International saw very little decline (approximately 2 percent) in overall membership during the past biennium, but any decline is disturbing. Our club also fell short of its goal of reaching 30 members by the end of the last biennium. I am hopeful we can reach this goal by the end of the current biennium. But, your help is needed to recruit potential members. At our August meeting, I will propose an incentive to recruit members for which I will seek your feedback.

I believe that we will work better together if we know each other better.
